Invitation for Bids for the construction of 15 bed hospital at Pheta rural municipality

- The Pheta Rural Municipality has allocated funds for the construction of 15 bed hospital at Pheta rural municipality and intends to apply part of the funds to cover eligible payments under the Contract for PRM/01/077/078
- 2. Bidding is open to all eligible as per Section V of bidding document.
- Pheta Rural Municipality invites sealed bids or electronic bids from eligible bidders for the Construction of 15 bed hospital at Pheta, Bara under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs 22,73,27,000
- Minimum Work experience of similar size and nature: [minimum one Building Project, minimum value of NRs 15,00,00,000]
- 4. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
- 5. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Pheta Rural Municipality Pheta**, **Bara** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
- 6. A bidder must download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders must submit their bid electronically and should deposit a non-refundable fee of Rs. 10,000.00 in the Office Rajaswa (revenue) Account as specified.

- 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at [1:00 PM on 2077/11/6 at the office of [Pheta Rural Municipality]. Bids must be valid for a period of [120 days] after bid opening and must be accompanied by scanned copy of the bid security in pdf format in case of e-bid,\amounting to a minimum of [Nrs.57,00,000.00], which shall be valid for 30 days beyond the validity period of the bid.
- 9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
